Reviewed Aug report for the 2013-2014 fiscal year. At year end BGSL had \$108,000 total of all accounts, the main club had \$96,000 and had \$136,000 in our Dupree account. At the end of August 2014 net income was \$49,000, with Gross Revenue showing \$52,000 better than budget, and expenses \$3,000 over budget.

In June 2015 we had \$210,000 total for all accounts, and the main club account \$99,000. And \$143,000 in Dupree

YTD revenue is down close to \$36,000 but the expenses are \$53,000 less than budgeted.

YTD we are \$35,000 better than budgeted, which includes timber sales.
