Financial Report

Mr. Nash announced recently discovered QuickBooks discrepancy of possibly +-\$60K. Have not been able to find source of error as of meeting time. Several questions from Piotrowski and Cox. Motion by Burgess, Second by Pinkston to table Financial Report until next meeting so that error can be investigated. **Motion passed unanimously.**

Old Business

Tabled Motion from August BOD meeting to reinstate the newsletter. Foley asked if expense was budgeted, Nash explained there was \$1500.00 in upcoming proposed budget. Motion passed with amendment of quarterly mailing.

KITCHEN – Harold Stevens reminded everyone to turn in their \$ or tickets from the fish fry. They need it to calculate "how they did"

RBurgess - mentioned BoD "responsibility" in past to buy or sell tickets and support the wild game division - youth - for the BoD. Please support and please attend.

No Committee Reports

New Business

- 1. **4-H-** Mr Creech would like to reserve 9/15/12 for the annual 4-H shoot. Muzzleloader directors said that conflict could be resolved for the use of the muzzleloader range. Motion by ? Second by ? to approve 4H use of facility on 9/15/12. Motion passed unanimously.
- 2. Initiation Fee- Much discussion about continuing reduced fee. Motion by Blackburn, Second Pinkston to keep initiation fee at current rate for ensuing 12 months. Mr. Cox inquired as to promo members paying fee. Promo members are exempt. Mr. Fister spoke against motion. Motion passed with Fister dissenting.
- 3. Fain Mattingly CPA- Mr. Miller turning over to Gary Nash re: bid from our CPA for book-keeping ~\$1500/yr Fain Mattingly discussed the summary scope of their duties/benefits to the League for \$1500; Mr. Nash propose that we keep them at that cost. last year was \$5400 Mrs. Johnson commented that last year a full review of all accounts was done last year- and requested to review results. Mr. Nash stated he has not seen it but would look into it. Motion by L. Johnson Second by Mulcahy to retain Fain Mattingly for accounting services. Motion passed unanimously.

- 4. Farm Vehicle- President Miller stated that his company had a 2007 Ford Ranger for sale approx 277,000 highway miles. He could get for approx \$1500-\$1800. Much discussion about feasibility, availability of budgeted funds and cost/benefit. Ben Riffle commented that it would greatly reduce fuel consumption compared to the current V8 farm truck. Motion by Foley Second by Haase to allow the Farm Comm Chair and Ops Manager to spend up to \$2000 to purchase a farm truck. Motion passed unanimously.
- 5. Budget- Proposed budget presented by Treasurer Nash. Many questions as reviewed line by line. Piotrowski inquired as to how renewal numbers were arrived at. Mr. Miller commented it was based on upward trend in renewals and a hopefully higher retention rate. Spike in February and March proposal was from the 1800 Promo membership and the projection that the approx 150 promo members that have attended orientation to date will renew. Less than a 10% retention rate budgeted for that promotion. There was much discussion on the past treatment of certain line items and proposals for future allocations. Went into closed session 8:57 pm for payroll budget discussion. Out of closed session at 9:09pm. Motion by Johnson Second by Foley to accept budget as presented. Motion passed with only Piotrowski dissenting.

Open shoots the fourth Sunday of each month for period October, 2011 through September 2012. Pistol matches the third Saturday of each month for period October, 2011 through September, 2012. This is an event open to BGSL members only. All policy will be followed for lead fees and non-member shoot fees. G. Nash: elaborated that discrepancies were present within Quick Books partially due to use of pre-formatted reports. Suggested online Quick Books at the cost of approx \$62/ mo. And that the club was now paying \$100/mo for Wild Apricot.

Discussion: The use of Wild Apricot questioned. The program was purchased but no one has in-depth knowledge of the program. At this time we have no contacts for any further instructions on the advantages of the programs. B. Ironmonger: stated the suggested use of Wild Apricot was for membership purposes. It is not financial software. Wild Apricot does have potential for website hosting as well.

G. Nash: When building Quick Books, there are differences in reports. And some reports are excluded. Gary said he would like to abolish preformed reports.

MOTION: W. Miller called for acceptance of financial report.

G. Nash: Questioned budget loss of -\$26,000 in the month of Sept.

D. Fister: Stated that the month of September has always seen fewer renewals. Maybe because of elections during that month.

R. Burgess: questioned how was the League -\$127,000 discrepancies in bookkeeping

Discussion: these figures reported from the year to date beginning June or July

W. Miller: The loss of \$60,000 was partly due to expenses not reported accurately.

B. Blackburn: mentioned that report failures have accumulated with errors over a period of 10-15 years.

Discussion: depreciation is accumulated yearly.

L. Johnson: still has questions where did \$27,000 go?

L. Johnson: why are the Dupree funds being used? Shouldn't the spending of these funds be approved by the BOD?

B. Blackburn: questioned Emergency Spending

OLD BUSINESS

W. Miller: Email was sent to BOD requesting notation of any problems within the league that needs to be investigated for any wrong doing. No response were received. Some of the BOD did not receive this email. This was resent by B. Ironmonger.

Hand Thrower at Trap - Investigation:

W. Miller had closed the trap after an accident was reported with a member. The BOD asked for a investigation determining safety.

C. Hasse: admits that this provides a important service to the members. After a investigation of the machine, he thinks that accidents are caused by operator error. Mr. Hasse stated if the handle was lengthened it will provide a safer cocking action. And he would like to post safety rules at the location, and re-open the trap in 2 weeks.

G. Richardson: Ask if other models have been reviewed?

C. Hasse: Yes but the others are not cost effective. And they would not with stand the weather or the extensive use that our present trap does.

W. Miller: stated that if suggested requirements are met that trap can re-open

FISCAL POLICY CHANGE:

A monthly statement will be provided to the Division President and Treasurer. This statement will detail all expenses due the Main Club from the Division. Supporting documentation will include the actual vendor invoices.

Division President and/or Treasurer will be given four (4) business days to review and either approve or dispute the amount in writing via e-mail to the BGSL bookkeeper and Treasurer.

On the 5th business day, BGSL bookkeeper and/or Treasurer will enact a bank transfer of the funds from the division level accounts to the main BGSL account in the amount(s) indicated/communicated and approved by the Division President or Treasurer. Failure to approve/dispute will result in automatic acceptance of the charge and funds will be transferred.

If the Divisions do not have funds available to cover the charges in total, an e-mail detailing the shortfall will be sent to the Division President and Treasurer. The Division must report to the BGSL Present and Treasurer, within 5 calendar days, an explanation and plan to reimburse the Main Club. Divisions that have outstanding invoices of more than 60 days will be subject to event cancelation at the Main Club Presidents discretion. Divisions not able to cover their operating expenses will be disclosed as part of the Treasurer's report at each BOD and General Membership meeting.

Renewal Dues - part of the conversion there will be changes with how the renewal dues are projected. Dues will no longer be counted as A/R. The dues will be presented as revenue at time of cash received.

Total A/R Adjustment of \$14,666 in past due member dues, actual cash received is \$29,000.

Roughly 147 members renewed in Oct.

L Johnson: asked if was a cash or accrual basis G. Nash: actually a modified accrual basis

D. Fister: Receivables were never figured with income prior in years

L. Johnson: questioned credit card service charges

G. Nash: stated that credit card charges is something that needs to be looked into further and promised that he would get those answers to BOD

L Johnson: asked about donations of \$5200 were posed under BGSL-E

G. Nash: answered that on the Balance sheet it should be posted in non dedicated fund on Dupree Account.

L. Johnson: questioned payroll taxes overpayment

G. Nash: stated that himself and S. Scarberry will review and follow up.

W. Miller: announced that no money had to come out of the Dupree account this month. Property taxes was paid with the honeysuckle money

Treasurer Report: By Gary Nash

Profit & Loss Report-

G. Nash stated that the actual income for the month of November \$91,498 – which shows a great improvement from previous months. This includes the \$31,000 cost share that we received from the Honeysuckle. For the month of December we are still looking strongly in our new member growth and renewals. 20 New Members to sign up in November, and 90 renewals. We are showing a profit of \$33,000. Which proves to be well over our budget at this time. Year to date we are exceeding our budget at \$3,360.

Discussion

M. Foley: questioned was the Honeysuckle budgeted for next month?

G. Nash: answered that we budgeted 31K for month of January. So we actually budgeted 2 months early. He stated that the budget should smooth out in February.

D. Fister: asked was net on cost share \$32,000?

B. Riffel: remarked around \$15,000 - \$16,000 net off of \$31,000

Balance Sheet-

G. Nash reported that the question that was presented for last month concerning BGSL-E of \$5200. It is now reported as a non-dedicated line that is cleaned out.

State Taxes overpayment – BGSL is now in process of receiving refund back from state. This matter should be cleared up by the first of February.

- **L. Johnson:** questioned the \$7250 in the Dupree acct.
- G. Nash: answered that it will credited as non dedicated
- **L. Johnson:** The non dedicated is now \$57.000
- G. Nash: answered that the Board voted that the tobacco buyout money was stored, for future approved projects.

Discussion

M. Foley: what are the possible remedies to get BGSL back on track? What do you recommend? **G. Nash:** answered that we have resources available as a club. With cost share programs, timber sales, we are replenishing. Utilize what we have, use the cash as the same club or we find ways to grow membership either in renewals or actual new members.

M. Foley: What point do we take action to re-establish the club?

G. Nash: We could consolidate amounts today with the exception of the tobacco buyout. By consolidating we will lose, we will not gain any profit.

J. Burke: stated BGSL needs to strictly force by-laws, that protect the tobacco buyout monies.

M. Foley: asked did the Board vote for taking \$33,000 out of Dupree account for advertising?

L. Johnson: answered it was taken out of the tobacco buyout money. No money was taken out of the lead remediation money for this.

M. Foley: asked for historical spending for the last 2 years on the tobacco buyout money? When was the first month the Dupree account was not attached?

M. Todd: said that \$7,000 was voted to be taken out to pay on credit card account last year.

G. Nash: Dupree acct was not touched for the months of Oct. Nov. or Dec. The last time was in September for payroll.

W. Miller: asked that we hold off on approving the Treasure Reports until we receive answers concerning the Dupree acct.

Farm Committee Report: Cost Benefit of Cattle & Timber

Rob Mulcahy: presentation performed from the Farm and Wildlife Committee

Reported that BGSL has approx 66 head of cattle as of December 2011

Sales Figures on cattle as November 27th is \$44,000 sold as they are.

Income from cattle in 2008-2009 was \$10,752. The year 2009-2010 was \$6,820 and 2010-2011 income reports of \$7,987.

Farm Committee recommends to Maintain the Cow/Calf Herd.

Trade in the older and non-productive cows. To maintain 50 cows in the next 5 years. Sale Feeders for income.

In keeping the cattle they do provide mowing services for the fields, which would cost \$25-\$35 per acre to keep mowed. To allow fields to grow for game fields would cost \$100-\$125 per acre. Currently the cattle are producing a better income than any other investment that BGSL has. There are 0 no guarantee of what cattle sales may bring in the future. But sales have been predicted to be at a all time high. Rob Amburgy of County Extension Agency, says that a strong market for cattle sales will be effective for the next 3-5 years.

BGSL Farm Labor- \$20,066

Which includes mowing and rolling 550 rolls of hay. 190 rolls cut and rolled was clean up for gun dog. 25 rolls for shooting tournament. These would not have been rolled for cattle use. 335 rolls were rolled for cattle with 225 rolls projected for in house use. Leaving 110 rolls for public sale.

F. Foster: asked if divisions reimburse the main club for mowing expenses

R. Mulcahy: No

The farm plan is to retain 8 Herefords for the year 2012, and to increase 3-4 Herefords for future years until we get total of 50 head of Herefords.

Discussion

B. Riffell: stated that \$2000 is projected from hay sales in 2012. Selling 130 rolls at \$15/roll. The plan is do custom rolling, to save equipment.

R. Mulcahy: Income increases over the next few years when the Herefords produce calves. The herd will be viewed and the culls will be sold

J. Burke: explained that cow/calf operation is more productive than feeders. Feeder prices and their weight can fluctuate throughout the year, where cow/calf are more stable.

R.Mulcahy: other option is to sell the herd. However it is recommended to wait until July or August. The club will lose a substantial amount of money to sell now.

M.Foley: is it safe to save if we are out of cattle business by July or August can we also cut labor cost on the farm?

R. Mulcahy: No. Along the roads still have to be mowed. Approximately 10% of labor is tending the cattle the rest of the time is operating and maintain BGSL Facilities.

M. Foley: asked do we cash out cattle now or do we stay in to receive the projected income?

R. Mulcahy: Labor cost will go up. Mowing will still have to be done on property where the cattle graze.

J. McClintock: asked are there other repairs that are related to the cattle?

B. Riffell: boundary fences are required to be maintained by law.

B. Riffell: we have 27 cows on hand to sell now with 1 springer. And 26 calves on the side. Sell of offspring is on the table. Selling feeders when we are cashed strapped is a far reaching decision. The 26 calves if sold now at their present age will have to be sold as cow/calf pair. Selling all will be anywhere from \$17000-\$18000.

Timber Update

R. Mulcahy: reported in his presentation that about 103,000 bdft of timber was marked for a selective harvest in the river bottoms. A rough estimate of value was given at ~ \$40,000. But, many variables influence this estimate. The harvest is primarily comprised of black walnut and yellow poplar.

Cost Share: We received \$31,239 on Honeysuckle. Phase II in the spring will bring another \$2500

W. Miller: presented answers to Mr. John Burkes questions that was presented to the Board. **J. Burke:** commended the League Officers for their efforts in answering his questions in such a satisfactory timely manner.

Outstanding questions last month was related to items that appeared on the general line. Example - Div 150 - \$ 233.50 contained 2 items. \$185 pistol division, and \$48.50 gun dog division. This money was collected from events, donations and are legitimate.

G. Nash said that there are talks how this can be categorized for a clearer picture in the future.

Farm Expense - In answering L. Johnson's concerns for the Farm Expense of \$2764. This amount was paid on the Farm Plan – John Deere Financial – credit card account. Purchases for supplement for the cattle, and payment on credit card from previous month's expense – carry forward balance from prior month, which included fertilizer, chainsaw maintenance, additional feed, engine oil, basic maintenance.

L. Johnson – mentioned that these expenses to be adjusted to set items. Where does it show up in category?

G. Nash – this is being reviewed and seeing what buckets these expenses can categorized in what division.

L. Johnson – says that there is not a category that food sales / concessions. And refreshments are different than food being sold. G. Nash – said that the finance committee has been discussing what can be done to the general chart of accounts. So that items can be categorized properly. What is the best way to redesign, so that it can be viewed per each division profit and loss? We will then be able to determine cost from each division.

M. Foley – asked L. Johnson, what constitutes food sales? Selling a hot dog is it considered donations or taxable liability. L. Johnson – answered if sold like a grocery store it is non taxable. But once you prepare food it is considered taxable. **Motion:** D. Fister / 2nd M. Foley to accept November financials Motion: Passes

December Financial

G. Nash: reported loss of \$21,237 for the month. Total income for the month \$41,891. Which includes \$20,000 from renewals. We missed budget, down \$9500 in total revenues.

W. Miller: stated that purchases in the shot gun venues cost approx \$13,500. Walter has asked the shot gun division for a month end inventory, so that these figures can be counted as an asset on the Profit & Loss report. That will appear as a credit, not as a expense on the balance sheet. Each month will show how many targets we have left and will be reported back. This will eliminate the high spikes. We will see a monthly use amount.

G. Nash: Another large hit was propone refills for the club house, this money was budgeted. Another cost presented is \$12,642 depreciation expense. This was not added in November, so this reflects a 2 month impact, which shows a \$600 adjustment.

L. Johnson: questioned \$114 income for credit card processing fees, and plus billing cost is \$1000. Are we working on getting the credit card fees to match our fees.

- G. Nash: we are looking on those charges, how to collect and reporting. We have some work to do on the actual process on the procedures that has been followed.
- L. Johnson: asked what the bank charges are.
- G. Nash: after reviewing \$370, I think it was coming back from the divisions, this is possibly a mis-code. This will have to be looked into further.
- L. Johnson: questioned Gross Payroll was budgeted \$150,000 for the year
- G. Nash: payroll represents \$6000 over budget.
- M. Foley: do we have trend data that shows which month's shows heavier employment, like farming activities, or due to weather for the month?
- M. Foley: asked for breakdown with payroll.

The BGSL has worked hard to provide a healthy deer herd with trophy individuals present. A wide variety of food and cover crops have been planted and managed in an effort to increase forage quality and concealment cover for our deer. Compound this with over 1400 acres (of which, several hundred are wooded) available to qualified hunters – and you have the makings for a quality deer hunting experience second to none. Hunters have the chance to harvest a true trophy whitetail on league property.

BGSL Deer Seasons (Overview)

Youth weekends are open to dependent youth of League members. It is a mentor hunt and a competent adult must accompany youth. Youth may hunt BGSL "fee exempt" during youth weekend(s); but, they must still follow the antler restriction guidelines and general qualifications for the BGSL property.

ALL STATE GAME AND WILDLIFE REGULATIONS ARE ALWAYS ENFORCED.

General Qualifications

Meeting the qualification minimum(s) for gun and archery is required prior to final approval to hunt on the BGSL. Interested members must qualify each year/season. Meeting standard in previous years may count toward the 2012-2013 season. (those qualified in 2011-2012 will be considered to have met the BGSL qualifications for the subsequent two seasons) New hunters or those who were unsuccessful in past attempts, must meet the minimum qualifications before going afield.

In order to hunt deer, you must:

Be a BGSL Member

You must be a member in good standing in order to apply to hunt. Please ensure that you have a current membership card at the time of hunter orientation.

Pass Gun or Archery Qualification Standards.

You may shoot anytime the ranges are open. RSO's on duty will have a "deer qualification target" available for those interested in qualifying with a gun. Once the standard is shot and met, the on duty Range Officer must sign the target.

(Gun qualification will be 4 shots at a distance of 50 yds. Three of the four must fall completely within a 6" diameter circle. For youth, the same standard applies – except they must shoot within an 8" circle. You may not fire an excess of 4 rounds/target or attempt to qualify more than three times/day. Archery qualification shall consist of 3 of 5 arrows in an 8" diameter circle at varying distances up to 30 yds. Those shooting traditional bows shall place 3 of 5 arrows within an 8" diameter circle at various distances up to 20 yards. You may attempt to qualify up to three times/day.) Those wishing to hunt with a handgun must qualify with a "hunt legal" handgun.

Present Completion of a recognized Hunter Education Course

Interested members will need to produce proof of successful completion of a state-recognized hunter education course.

Pay the Associated Fees

Associated fees must be paid prior to hunting on the BGSL. The current fee structure is as follows:

Either Sex Deer: \$40 small game (required) + \$260 either sex = \$300 Antlerless Deer: \$40 small game (required) + \$40 antlerless = \$80

Complete a BGSL Hunter Orientation Class

Participants must attend BGSL hunter orientation class (led by the Operations Manager or designated BGSL substitute) prior to going afield.

Harvest Limits

A two deer / BGSL hunter per season limit for both antlerless and either sex hunters is anticipated. (you cannot kill more than 2 deer on the BGSL, regardless of the county's designation) The exact harvest limit is tied to the final quota recommendation and hunter participation.

Harvest Quota

The BGSL works closely with the KY Dept. of Fish and Wildlife Resources to determine a good estimation of our deer herd's numbers, health, and potential. A harvest quota will be set after surveys are taken and a state biologist makes a recommendation for this year's harvest. Once obtained, this number will be made available to the hunters.

Deer Tags

A hunter will use his/her own tag for deer harvested on the property. No "special harvest tags" will be issued.

Antlerless Deer

"Antlerless Deer" on the BGSL are considered by the same definition as those outlined in the state hunting regulations. However, we STRONGLY encourage the harvest of adult does.

Antlered Deer

Qualified "either sex" deer hunters have the option of harvesting an antlered deer on the BSGL property. The BGSL does have a minimum standard when harvesting antlered deer. Deer must have a minimum antler spread of 15". Please be sure that your deer meets this standard before you shoot. If a deer does not meet these standards, you may be subject to discipline from the BGSL Board of Directors. Shooting a marginal buck is not worth your membership!

Lawful Equipment

Archery Equipment must meet state minimums. Crossbows are allowed during regular archery season by those individuals requesting a hardship/disability exemption and able to produce documentation that they are allowed by the state game department to utilize crossbows during regular archery season. Crossbows are also considered lawful equipment during the statewide crossbow season. The use of modern firearms on the BGSL are restricted to shotguns or muzzleloaders meeting state minimums for deer, straight walled pistol cartridges up to 44 magnum caliber shot in a handgun, & straight-walled pistol cartridges up to 44 mag in a long gun.

Checking / Tagging Harvested Deer

ALL deer must meet state telecheck standards and the BGSL must have a confirmation number recorded beside the hunter's name in the hunt logbook before the deer is transported off the property. BGSL staff must also be notified and the deer inspected (by a BGSL employee or a member of the wildlife committee) prior to leaving the property.

Hunter check-in and check-out procedure

All approved BGSL hunters must check in at the start of each hunt and check out at the conclusion of their hunt. This needs to be done each time and for every hunt. The hunt logbook serves as the record of checking in/out. Please fill the information out correctly and completely. Further details will be covered in the scheduled hunter orientation classes.

Baiting

Baiting deer and wildlife on the BGSL property is prohibited. Salt, sweet syrups, and other common deer attractants are considered bait.

Tree Stands

Permanent tree stands are not allowed. Tree stands that damage trees are not permitted (i.e. "screw-in type" steps, etc.) ALL stands/blinds must be labeled with the owner/hunters name and address. They may be erected no earlier than 4 weeks prior to season opener and shall be removed within 2 weeks after the BGSL season closes. Stands improperly marked or found in the woods outsides the specified times/locations are subject to immediate confiscation and the owner (if known) may be assessed a fine. Additionally,

they may have their hunting privileges revoked. Pop-up style blinds are subject to the same labeling and date restrictions as are tree stands.

Driving off Roadways

You may drive off a roadway and through fields only to hang a stand, erect/retrieve a stand, or to retrieve a harvested deer. In all cases, requests should be made to BGSL staff prior to leaving a road. Please be mindful of the time and location of other hunters when you do leave the roadway. Help preserve the hunt quality for others.

Restricted Areas

Due to the nature of the League, certain areas may be closed to hunting for safety and or event conflict rationale. Closings may vary and come with short notice. Please keep yourself informed by faithfully checking the information board located by the hunter logbook in the foyer. Some of the general locations that will be closed to hunting are:

All ranges and the area immediately around such ranges. Please observe a 100 yd. "no hunt" buffer around all ranges/buildings

Hunting from buildings is prohibited (includes barns)

The Gun Dog Division training fields are off-limits

The area inside the "paved loop" on the main road and pasture lands around the main clubhouse.

This is NOT a full list. Please be attentive in orientation class and observe all temporary closures posted.

No guarantees - No Refunds

This is not a "no kill no pay" hunt situation. Meeting all qualification standards does not guarantee you a filled tag at the season's end. All hunts are fair chase with 100% wild white-tailed deer. Hunts may be restricted or amended as events evolve (i.e. harvest quotas are met, disease in the herd, etc.) There will be NO REFUNDS.

Violations

Again- STATE GAME LAWS ARE ALWAYS ENFORCED. Additional rules may be applied by the BGSL Board of Directors. Please educate yourself on the "can do's and the can not's" that come with hunting on League property. Be a good sport and live out the ideals that this club extols. Don't break the rules and insist that others do the same!

State Wildlife Laws/Regulations Always Apply

Small Game Orientation Class

All qualified hunters must attend a scheduled "BGSL hunter's orientation class" before hunting on BGSL property. During this briefing, hunt guidelines will be reviewed and hunters will be informed of any changes which may be pertinent to their small game pursuits. Members must attend this orientation EACH year.

Hunt areas &restricted locations will be outlined during this orientation class. Areas may open or close to hunting due to a variety of factors. Some examples are: open events, logging/forest operations, deer hunts, upland bird hunts, etc. Please keep yourself updated by regularly checking the information posted at the hunter check-in station (located at the main clubhouse foyer area)

Equipment Permitted

Due to safety concerns, rifles may not be used to harvest small game on the BGSL. Legal shotguns shooting #6 shot or smaller may be used. Airguns of adequate power may also be used in the pursuit of small game.

Minimum Requirements

All participating members must:

- Be a current member in good standing with the League
- 2 Possess a valid KY hunting license
- 3 Pay the associated fee(s) and attend the required orientation class before going afield.

Small Game Fee(s)

There is a \$40 small game fee assessed to qualified hunters wishing to pursue rabbit, squirrel, crow, or dove on the BGSL. In an effort to promote a positive hunting experience & maximize family participation, the BGSL small game tag will be considered a "BGSL

membership small game tag". This means that the fee paid by a qualified member shall also cover his/her spouse & minor children when hunting in conjunction with the qualified member.

Guidelines Regarding Youth Hunters and Guest Hunters

In a further effort to introduce a new generation of people to the hunting tradition, approved small game hunters may take up to two youth (as defined by the KDFWR) per hunting adult w/o an associated fee. They will, however, need to complete a no-cost liability waiver (located on the table by the hunt logbook) before hunting.

BGSL Trapping:

While trapping is a valuable management tool, the Handy's Bend Property is also a multi-use recreational property. ALL members interested in trapping must meet with the Operations Manager for a "furbearer orientation". This orientation is completely SEPARATE from the BGSL small game orientation.

Snares and body-gripping traps ("conibear-type") are prohibited from use at the BGSL.

Leg holds, specialty traps, & live "box" traps are permitted.

Specific locations and restrictions are TBA. The member fee assessed to qualifying members shall be \$40. This is a fee applied specifically to those trapping furbearers on the League lands.
