

# 2018 Parent/Guardian Consent Form for Youth (under age 18) to Possess and Use Handgun and Ammunition at Blue Grass Sportsmen's League

In recognition of the provisions of the Youth Handgun Safety Act as set forth in the Gun Control Act of 1968, 18 U.S.C. Chapter 44, I declare the following:

- (1) That I am the custodial parent or guardian of a juvenile named \_\_\_\_\_ whose date of birth is \_\_\_\_\_;
- (2) That I, myself, am not prohibited by Federal, State, or local law from possessing a firearm;
- (3) That the above-referenced juvenile has my permission to possess and use a handgun and ammunition for the purpose of participating in regularly scheduled monthly IDPA pistol matches **held during 2018** at the Blue Grass Sportsmen's League in Wilmore, Kentucky.

I understand that these IDPA matches at the Blue Grass Sportsmen's League involve a form of "target practice" whereby the participant fires a handgun at multiple targets during several "stages," or courses of fire.

The undersigned parent or guardian has the right to revoke this consent in writing by providing a signed, written revocation to Lin Edwards at 4092 Bridgemont Lane, Lexington, KY 40515-6032.

**RELEASE:** Due to my child's participation in any activities sponsored by or held on the property of the BLUEGRASS SPORTSMEN'S LEAGUE, I do hereby release the BLUEGRASS SPORTSMEN'S LEAGUE and the BLUEGRASS PISTOL CLUB, their officers, and servants, and any other contributor, sponsor, or affiliate from all liability which may arise out of loss, damage, injuries, or deaths which my child may sustain during these activities. I acknowledge that I am over the age of (18) eighteen years and that I am aware of the risks and hazards inherent upon competitive shooting matches, including but not limited to accidental discharge of firearms and loss of property through misplacement or theft. I further acknowledge the right of the above mentioned to terminate my child's participation immediately upon his/her failure to comply with all the rules, regulations and directions of the club officials. I further state that I have read the foregoing participation agreement and release and freely enter into it on behalf of myself and my distributors, heirs, next of kin, executors, and administrators.
