- Recent Heartbreak Run-N-Gun was a success bringing in approx. \$1,900 profit.
- Bill Wittman and Jim Lurton have built a new jig for constructing walls and have thus far
 manufactured 18 new walls. These new walls need to "skinned" and the appropriate materials

 walls.
