President's Corner

My fellow Sportsmen,

My time in your service will soon change from President to Past President and I have resolved to educate you, the owners of this great League to the modern issues we owners face today.

At the July meeting of the General Membership, I presented a "State of the Blue Grass" address. I called a "Special Meeting" of the League on July 7th and repeated the presentation. The idea was to show you a real-time picture of all aspects of the BGSL. I wanted to do this in my 1st term {2004/2005} but quickly realized that it was not possible.

I was not educated enough! I still was a bit hesitant even now, 2 years later but feel very strongly that this was needed. This is a very complicated organization. Although the turn out and participation was less than I'd hoped, it is my opinion that the membership should put forth a motion to compel this address and presentation to become a yearly event.

This address was and should be my opinion and observations as BGSL President, based on my experience from this position. I pointed out the deficiencies and solutions. I spoke to the issues that the membership should want to know about and affect the club's government, communications, membership and finances. The government portion covered the Board of Directors, the Standing Committee's, and the Operations and Administration. The finance piece was the portion that most folks were interested in. I presented the up to date figures of income and expenses, the members share value and broke the finances down by a summary of the categories. The most participation was over this issue and again the farming operation and its issues were the topic of choice.

The "FARM", "again". This issue has been a bone of contention since I can remember. It has been my experience that most of our owners do not understand this issue. I've heard it all and from every angle. The bottom line goes back to understanding. We do not "farm" because we can, we don't farm because we have 1400 acres and we don't farm because farming is such a great business.

We farm for much better reasons; we farm because we get the benefit of offsetting operational expenses in the farming operation. We farm because farm taxes are much cheaper than commercial taxes. We farm because our Constitution says we will. It says we will because of those reasons. Farming is good stewardship of our land and that is our first priority. I have heard many times; "I did not join a farm", "farmers can't make any money", "we aren't farmers". I've also heard; "why don't we maximize the cattle heard", "why aren't we boarding horses", "we should plant more alfalfa and native grasses".

Most folks, who have a problem with this issue, that take the time to educate themselves to our farm operation, wind up agreeing that we should be farming. Maybe we should rename the "farm" to "land stewardship".

No matter where you stand on this or any issue at this great club, as an owner you should educate yourself to the issues and how they affect our bright future.

The following motions were voted on:

Motion #1 by Jacobs, second by Maness to dispense with reading of minutes and accept the minutes as presented. Motion carried unanimously. **Motion #2** to accept the treasurer's report as presented carried unanimously. **Motion #3** to waive the guest fee for Saturday, June 30, 2007 carried unanimously. **Motion #4** to continue having the newsletter printed by Insty Prints and **Motion #5** to table **Motion #4** carried unanimously. **Motion #6** to table the proposed training policies carried unanimously. **Motion #7** to amend the lead remediation fee policy to read as follows: "In addition to the member assessment, the one cent (\$.01) per shot be assessed on any shooting activity on BGSL property where fees are charged by a division or group not exempted by the Board of Directors in advance. 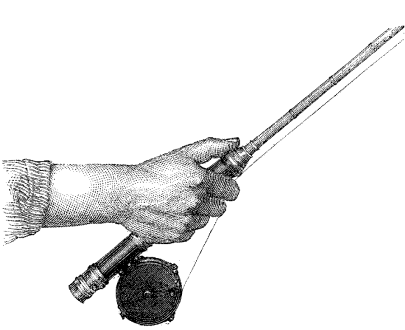

(BOD Minutes continued) There was much discussion on this issue. Motion passed with 3 board members dissenting. **Motion #8** to approve the Duck Unlimited use of the clubhouse, kitchen and casting ponds on Saturday, August 4, 2007 carried unanimously. **Motion #9** to approve two Conceal Carry Classes on Saturday, August 11 and Saturday, September 8th to be taught by Brandon Ironmonger carried unanimously. **Motion #10** to approve an Advanced Pistol 1 and Advanced Pistol II taught by Lin Baxley and sponsored by Lin Edwards for October 12-13 and October 14-15, 2007 failed by a vote of 8 to 11. **Motion #11** to amend the motion to include a \$100 per day non-member use for the clubhouse for the class fee structure or a total of \$400 failed by a vote of 7 to 12. **Motion #12** to approve a NRA Basic Pistol Class taught by Breen Combs and Lin Edwards on Saturday, July 21 and Sunday, July 22 pending availability of classroom space carried unanimously. **Motion #13** to adjust existing Practical Pit Rules to allow rifle shooting in all six bays of Pit #1 carried unanimously. **Motion #14** to allow BSA Troop 40 (David Field, Scoutmaster) to bring approximately 10 scouts and 3 adults to use our campground on the evening of Saturday, August 4, 2007 and use under supervision, the rifle range and archery range carried unanimously. **Motion #15** to allow an Ad-hoc Committee to draft a member survey, to be approved by the Board at the next meeting, and to be published in the Sportsman's Trails and BGSL Blast to assist in determining the future directions of the BGSL carried unanimously.

The following committees reported: Constitution and Bylaws, Farm, Wildlife and Natural Resources - President Delabar stated that Craig Phinney was unable to attend the meeting but reported that the final details of the Put and Take Operation will be presented at the July meeting. President Delabar also reported that the first deer survey will be conducted early Saturday morning. **Security Chairman Dr. Blackburn reported that there was an unauthorized access through the front gate by member(s).** Dr. Blackburn stated that

the Security Committee has recommended a letter of reprimand to the member and a probationary period for the member. Dr. Blackburn requested that the gate procedures be re-published in the Sportsmen's Trail, Youth

The following AD HOC COMMITTEES reported: Membership Committee- Tom Cottingham stated that the membership committee needed volunteers for the orientation scheduled on July 21. Ken Maness and Rolly Beers volunteered, Training Committee - Mike Pinkston presented the guidelines, action statements and mission of the Training Committee and asked for the Board to approve the proposed training policies. There was much discussion on this issue. Trails – John Ruland and Harold Moore distributed a walking trail map. Mr. Ruland asked that the map be published in the next issue of the Sportsmen's Trail. President Delabar and the Board Members stated thanked John Ruland and Harold Moore for their efforts. Signage -President Delabar stated that the Division's request for signage should have been submitted to the Board for approval.

Old Business: Shooting Berm and Lead Remediation. President Delabar stated that a policy had been previously approved but an amendment is necessary. Appleseed Program -Clay Caudill stated that the dates of October 6 and 7, 2007 have been finalized for the Appleseed Program at the Bullseye Range. New Business: Duck Unlimited Request for use of BGSL President Delabar noted that Ducks Unlimited is requesting use of the clubhouse, kitchen and casting ponds for a volunteer Appreciation banquet on Saturday, August 4, 2007. Ad Hoc Committee for Membership Survey-- President Delabar appointed Dr. Bill Blackburn, Dan Fister and Robbie Mulcahy to draft a member survey to be published in the Sportsman's Trail.

United We Stand, Divided We Fall

Assault Rifles For Hunters?

As I write this, I'm hunting coyotes in southeastern Wyoming with Eddie Stevenson, PR Manager for Remington Arms, Greg Dennison, who is senior research engineer for Remington, and several writers. We're testing Remington's brand new .17 cal Spitfire bullet on coyotes.

I must be living in a vacuum. The guides on our hunt tell me that the use of AR and AK rifles have a rapidly growing following among hunters, especially prairie dog hunters. I had no clue. Only once in my life have I ever seen anyone using one of these firearms.

I call them "assault" rifles, which may upset some people. Excuse me, maybe I'm a traditionalist, but I see no place for these weapons among our hunting fraternity. I'll go so far as to call them "terrorist" rifles. They tell me that some companies are producing assault rifles that are "tackdrivers."

Sorry, folks, in my humble opinion, these things have no place in hunting. We don't need to be lumped into the group of people who terrorize the world with them, which is an obvious concern. I've always been comfortable with the statement that hunters don't use assault rifles. We've always been proud of our "sporting firearms."

This really has me concerned. As hunters, we don't need the image of walking around the woods carrying one of these weapons. To most of the public, an assault rifle is a terrifying thing. Let's divorce ourselves from them. I say game departments should ban them from the praries[sic] and woods.

Wow. Read *that* again. Read *that* again.

You may recognize the 255 words above. They were written in a web log (blog) by a writer with the magazine *Outdoor Life* named Jim Zumbo. If you are familiar with the situation, you know that Mr. Zumbo is now pretty much out of work – dropped by his employer, industry manufacturers, and kicked around by internet blogs as well as other outdoor writers. To be complete, I copied the above text from another blog at (<http://michaelbane.blogspot.com/2007/02/serious-stuff-jim-zumbo-defection.html>) since *Outdoor Life* has removed it from their site. Zumbo got himself in such a stew because some anti-gun groups and politicians picked up his comments and began incorporating them into the steady beat of press against gun related sports. Several sources say that Zumbo's comments were used by the Congressmen while debating proposed legislation to renew and expand the assault weapons ban (the very ironically named HB 1022)

I've been following this story since shortly after it began in February. I thought it had lots of interesting implications. With the current buzz about the future direction of the BGSL, I have been part of, or heard several discussions where the meaning of "Sportsman" eventually gets kicked around. Are we a hunting club or a shooting club? Zumbo's comments, those conversations, and President Delebar's "President's Corner" in July's Trails convinced me to write.

The futures discussions go into a related "off limits" topics. You know the kind – where people suddenly dummy up, get uncomfortable, and look at their shoes when politics and religion are discussed. The topic is "black" guns vs. "blue" guns. For the unaware, "Black" guns are typically guns designed and finished in more modern styles (i.e. AR's, AK's, Glocks, etc). The metal usually has black oxide coating plastic stocks/grips and high capacity, quick change magazines. "Blue" guns are more traditional blued metal and wood stocks/grips, low capacity, slow to reload magazines.

Zumbo stepped right in the middle and helped define the argument when he wrote: *I've always been comfortable with the statement that hunters don't use assault rifles. We've always been proud of our "sporting firearms."* Zumbo said on a national scale what I hear at BGSL: "We are sportsmen. Sportsmen don't use black guns or do 'paramilitary or 'police type' shooting - we don't need to be doing that kind of stuff here". I've heard it said another way: "he shoots a Glock, he's not a sportsman", or "no sportsman would try to shoot 300 yard targets with an AR", or "no one shoots skeet with a black semi shotgun". Or the infamous "He's a sportsman" with a wink implying the guy shoots the right color gun, but nothing else about his character.

This is why Zumbo's debacle is relevant to the BGSL: the term "sportsman" has become a divisive term – a code word if you will – a way for one group to label and exclude individuals based on something other than character. Pretty dangerous situation when we are thinking through the future of the Sportsmen's League.

So where do we go from here? Let's look at 2 fundamental sources: the dictionary and our own BGSL Constitution. Look up "sportsman" on dictionary.com and you get: *-noun, plural -men. 1. a man who engages in sports, esp. in some open-air sport, as hunting, fishing, racing, etc. 2. a person who exhibits qualities especially esteemed in those who engage in sports, as fairness, courtesy, good temper, etc.*

There is no exclusion of a person who doesn't shoot a particular type of gun at a particular type of target from being a sportsman. Yeah, I know, hunting and fishing are mentioned, but so is racing, etc. Look at that second definition. Isn't that the one that counts?

Now look at the BGSL Constitution. Article II, Item 9 reads: To acquire the use of suitable land necessary to promote the desired projects of the League, such as skeet, trap, rifle, and pistol shooting, archery, casting, field trials, sportsmen's shows, and other sporting activities that may be conducive to the entertainment, health and happiness of the members and assure the success of the League.

From the BGS� Chaplain



Did you know that Kentucky now has an official state music? Not only that, but it is one of my favorite kinds of music: Bluegrass! Just a few weeks ago I attended a ceremonial signing by Governor Fletcher of the house bill that made it so. (I understand the governor is a member of BGS�; do you suppose he knows I am his chaplain?) Our state has a number of official symbols: our state fish is the spotted bass; our state bird is the cardinal;

our state mineral is coal; our state flower is the goldenrod; and our state drink is milk...not bourbon!

There are a number of other symbols Kentucky has adopted down through its history to represent our state. To me, none is finer, and none more correct, than our state flag. The blue field of the flag surrounds the state seal. It is this seal with its motto that defines Kentucky. On the seal are two men, one in buckskins and the other in a swallowtail coat, greeting one another in an embrace. Around them is our motto: United We Stand, Divided We Fall.

The seal and motto are credited to our first governor, Isaac Shelby, who was a hero of the Revolutionary War. The two men symbolize the coming together of Pioneers and Gentlemen, representative of very different points of view, who are working together to attain common goals. The motto itself is from The Liberty Song, which was popular during the war and favored by Shelby. We have a

fine heritage in this flag and its seal. Working together is the way to insure success.

We are facing some financial obstacles in the life of BGS�. We cannot go on indefinitely with a deficit budget. Nor can we go forever without spending some major money on maintenance items such as repairs to the clubhouse. We all agree on that part; we are divided on how to solve it. It is okay that we do not all see it the same way, but it is not enough to simply say we agree to disagree. That does not get us where we need to be. Just as the two very different men on the State Seal stand united, we need to stand united. I believe there is more than sufficient talent and dedication within this club to come up with a solution. Together, we can find a plan that will work.

Easier said than done? Yes, it is. But we can do it if we choose. How to start? Keep talking about solutions and listening to opposing viewpoints; listen carefully and zero in on the parts that do make sense to you. If we will all do that, identify those places of agreement, common ground can be found. On that common ground we can stand together! See you at the club.

While the framers were not familiar with IDPA, USPSA, or target shooting with an AR15 at 300yds, etc, they did not rule it out. In fact, I think they purposely left the door open with terms like "sporting activities...conducive to the entertainment..." and "...assure the success of the League". A Pretty smart group, 60 years ago.

This brings us to another fundamental source. Recognize this? "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed." Another group of smart people, 230 or so years ago.

Now to today, and another slogan: *United We Stand, Divided We Fall*. A few may be unfamiliar with this one. It is on the Kentucky Flag, and is the official motto of the Commonwealth. The United States, The Commonwealth, and The BGS� are all here now because a group of people had the foresight to take lessons from the past and use them to shape the future.

What will we do? Please keep in mind the real definition of Sportsman as we make critical decisions on the future of the League. And no matter which side you are on, reach across the "Sportsman Divide". You'll probably learn something and find true sportsmen there as well.
