

Morgan's Meanderings By Terry C. Morgan



I don't know about you but I have been inundated with information about the various aspects of Swine Flu (or N1H1 if you prefer) and I do appreciate our news media being concerned about our national health issues and I have actually seen and heard some enlightening information about the subject that was not filled with fluff, hyperbole and sensationalism. From the BGSJ Chaplain

Last month my wife, Judy, and I went on a family vacation that included our two youngest grandchildren. We spent a week in a chalet in the Smokies where I got to be a full-time Papaw. There are some duties involved with being Papaw. First of all, Papaw, and no one else, must be the one to put little ones in and out of car seats. Papaw must always read *"Bedtime for Frances,"* or, *"Frog and Toad Are Friends"* when requested...at least seven times in a row. But, most of all, whenever Papaw has a bowl of ice cream there will instantly be a little girl on one side and a little boy on the other. And, between the two of them, Papaw most likely will not get even a taste. I wouldn't have it any other way.

The day we came home from our trip my granddaughter was sick and had a high fever. The next day my grandson had the same illness. They both had the H1N1 virus. Being healthy little children, they both recovered very quickly. Somehow through it all, Papaw, er that is, I, didn't get the virus. But I did learn a little about H1N1 during the process; and I want to share it with you.

The only ways H1N1 can enter the body are by way of the nostrils and mouth and throat. Since this is a global epidemic, you can't avoid coming into contact with the virus no matter what you do. But contact does not necessarily mean illness and secondary infections. It takes 2-3 days after the virus enters the nose or mouth to proliferate to a level that will cause symptoms. There are some simple precautions that will help prevent the virus from growing and they do not include trying to get hold of N95 or Tamiflu.

Wash your hands. *A lot.* Hand sanitizer is a good substitute.

Don't touch your face. Of course, there are some necessary exceptions to this one.

Gargle at least twice a day with warm salt water. You can use an antiseptic rinse if you must, but the warm salt water works just as well. It is said this has the same effect on a healthy person as Tamiflu has on an infected one.

Since the nose is the other danger zone, clean your nostrils with warm salt water.

Eat foods rich in Vitamin C. If you get your C in tablet form, make sure you also get some Zinc to insure its absorption.

Drink a lot of warm liquid. This washes the virus into the stomach where it can not spread or do other harm. That proves what I have always believed: coffee is good for me! Coffee may have saved me from the flu.

I hope this information will help you avoid the H1N1. Stay healthy so you can enjoy all the sporting activities we love. We will be booking the same chalet for next Spring and I will be on duty as Papaw again. I can't wait. See you at the club.
