Court system (at a profit) with a lifetime conservation easement upon the deed. This would ensure the area be open to public hunting and fishing in the future. A resource management plan for the property must also be implemented. Mr. Allen also indicated that the LKS is potentially considering another land acquisition for similar ends.

Mr. Allen announced the upcoming LKS Board meeting and the upcoming 6<sup>th</sup> district federation meeting times and location.

President Mulcahy recognized Ken Maness to speak.

Ken Maness - took donations for underprivileged families in the community. The money collected that night would be (at the request of the local community center director) donated to the Nicholasville Fire Department for purchase of Christmas toys for area youth. The money collected at the December General Meeting would be used (again - at request of community center director) to help replenish the local food bank inventory. The hat was passed.

**Financial Report** 

Dan Fister: stated that some of the

reports had been changed in the format in which they were presented. Discussed that he would now be showing the main club plus the divisional assets. An overhead of the financials was shown. Dan Fister again stated some differences in the accrual basis that was shown versus the format the information had been presented in previous meetings. Report showed a net income of -\$16758.10.

# **Greg Delebar** asked to be recognized,

Stated he had recently moved to GA and immediately looked for another "BGSL"; he stated a couple are there - (comparable clubs that offer what we offer) - he stated that such clubs have fees of \$10-\$12,000 /yr. He stated a comparable club he researched had a 5 yr. Waiting list and another had a 3 yr wait list. He noted that our money was "out there" in the public and we had to focus on membership and getting new folks in the gate. He stated that we "don't know what we have here" and that "you all don't fully appreciate it until you

move and see prices /service of comparable clubs"

**Dan Fister** - stated that we could fill our rolls if every member recruited just one member – and start a waiting list. He encouraged members to recruit.

Mark Dacci spoke to his concerns about the front gate being open. He felt nonmembers would now be using our facilities w/o supervision at our expense. He felt this was contrary to the intent of the founders and tradition and "the open gate policy MUST stop!" There were insurance coverage questions and Mr. Dacci strongly encouraged everyone to push/force their directors to oppose this concept.

**Fred Foster** – stated he felt that some critical aspects of the policy had been left out by previous speakers. He stated that 75% of net profit was coming back to the main club from Trap/Skeet Divisions for allowing them to be open 5 days a week with the Gate open. The intent of the policy was to allow greater access to the division(s) that are willing to re-invest back into the main club.

Dan Fister- stated that he believed the gate was open often at the old club and our history here (BGSL HANDY BEND) also had long periods of time where the gate was open. There is a RSO staff now full time on the ranges. Operations are still on site. He felt it was an asset to members and non-members alike – he had no problem with the motion.

**Tom Tryon** – stated that he felt it was a benefit to prospective members and good for membership. He brought up the cost savings to the Main Club through the reduction of the Nextel phone package – totaling approx \$5\$7,000/yr.

Walt Miller stated "the 800 lb. guerilla in the room is the budget" we are projected for a \$175,000 shortfall in the Budget this year. That equates into \$320/yr dues for the members or have each division come up with \$16,000/yr to give to the Main Club

This new policy helps the shotgun Divisions expand services and a chance to give something back to the Main Club.

#### Jim Gaddis -

Spoke to the RSO presence on the ranges and how he has personally seen a reduction of non-authorized range use because of staffing. He felt the risk of BGSL Range use by non members due to the gate being open was minimal

Mike Kass – Thanked Tom Cottingim for donating the amp for the PA System in the main clubhouse. Membership approved this recognition through applause.

**Rob Mulcahy** announced the kitchen menu – Thanksgiving dinner of turkey beans, mashed potatoes, rolls, gravy, cranberry sauce and homemade desserts.
