July 2016 showed for all combined accounts \$187,532.56 with \$62,757.37 in Main account and \$155,047 in Dupree

July showed an increase in membership income of \$500. Division Income is about even to what was budgeted. Division Expense was up. We had a net loss of \$15,500. Which was \$14,850 under budget. Division Expenses contributed to the biggest portion of loss.

August 2016 for all combined accounts \$201,531.20, with Main account \$67,826.70 and the Dupree account we had \$155,762.15

Reporting under \$2000 in membership, with a loss for YTD \$15,500, bulk of members did not renew. Division Revenue down \$41,000 more than budgeted. Growth of activities showed division expense of \$72K increase. Net income \$3354. Better than Budget \$3200. With a Net Loss \$8,000.
