Proposed By-Law Change Dues **Bluegrass Pistol Club** February 12, 2019

Current By-Laws (adopted 8/17/2010)

Annual membership dues for the Club shall be \$20.00 payable on January 1st of each year. Multi-year memberships are available at 3 years for \$50.00, 10 years for \$150.00 and Lifetime Membership for \$300.00. All memberships will expire on December 31st of each year regardless of the date that the dues were paid. There is no initiation fee to join the Club.

Proposed By-Law wording change

Annual membership dues for the Club shall be payable on January 1st of each year. Memberships will expire on December 31st of each year for annual memberships and December 31st of the appropriate calendar year for multi-year memberships. There is no initiation fee to join the Club. Annual membership dues shall be reviewed yearly by the Club Officers who shall recommend an annual dues amount to the membership. The membership shall be given at least 30 days' notice prior to an approval vote. The recommended annual dues amount must be approved by a majority of voting members present failing which the annual dues amount shall remain unchanged until the succeeding annual review. In no circumstance shall the cumulative increase in annual dues exceed 25% in any three calendar year period.

Multi-year memberships are available at the following rates:

3 Year membership Life membership

(3* Annual dues) - 16.7% 10 Year membership (10* Annual dues) – 25% 15* Annual dues
