Total for all accounts in May was \$262,336.02 Total loss for all divisions is \$7,307.66 Consolidated P&L shows a total loss of \$31,601.32. This is \$22,988.32 greater loss than the budget's projected loss. The total gross income is \$66,828.65 below the budgeted amount.

PPP Plan gave the club \$56K in assistance with payroll during the pandemic outbreak.
