Total Cash All Bank accounts \$ 384,251.69

The Dupree account total value is \$249,072.63

Total YTD profit for Operations (Main Club, Farm and GP Range) is \$36,386.93. Both Main Club and Farm show a total profit of \$53,029.59, while the GP Range shows a loss of \$16.642.66.

Total Operations YTD income is \$242,406.75. This is \$368.25 below YTD budget.

Renewal Dues are running \$46,808.50 below the budgeted amount. New Members is almost \$24,200.00 above the annual budget amount.

Total YTD expenses are \$25,852.57 below YTD budget.

The net result of all this is YTD Operations Net income being \$25,666.93 above budget.

**Roof** - received 2 estimates on main club house roof repair/painting. Questions on these repairs were what is the guarantee and expected lifespan of material? More information needed before deciding on the roof.

**HVAC** – the club received 4 estimates for heating and air. After reviewing the provided estimates with questions and answers to follow a decision was made.

The gate will be closed at all times other than during large events and active pistol pit pass holders will be allowed access my means of a unique pin number that will be entered on a keypad at the gate location, which will be on the pistol pit side of the road split between the pistol pits and the loop road to the old archery area/muzzle loader range/shotgun range. With the passing of this motion, the Pistol Division will be authorized to spend up to \$12,000 of Pistol Division funds to facilitate the installation of the access gate.

Signage will be provided to indicate that access requires Pit Pass Certification.
