Total Cash All Bank accounts \$357,764.35

The Dupree account total value is \$285,345.15

Non-Dedicated contains the following allocated funds...

\$31,000 Main Club ammo

\$25,000 Club House Roof Painting

Thus reducing Non-Dedicated balance to \$64,176.88 in available funds and Total Dupree to \$229,345.15 in available funds.

Total YTD profit for Operations (Main Club, Farm and GP Range) is \$3,175.38. Main Club shows a total profit of \$39,722.40, while the Farm and GP Range show a combined loss of \$36,547.02.

Total Operations YTD income is \$393,698.10. This is \$8,964.77 above the YTD budget.

Total Dues are running \$7,701.36 (about 2.4%) below the YTD budget amount

Total YTD expenses are \$4,381.18 above YTD budget. Keep in mind there have been \$38,300.00 in capital expenditures and \$3,609.60 Wildlife Committee expenditures made which were not included in the annual budget.

The net result of all this is YTD Operations has a net gain of \$3,175.38. This is \$9,643.71 above the YTD budgeted loss of \$6,468.33.
