# Treasurer Report: by Ron Summers

Currently the main club has \$98K in the checking account

Total Cash All Bank accounts \$328,201.79

The Dupree account total value is \$288,120.38

This includes \$32,000 in member payments for ammo purchase and \$25,000 legal fees reserve included in Non-Dedicated Funds.

Total YTD profit for Operations (Main Club, Farm and GP Range) is \$5,167.90. Main Club shows a total profit of \$9,990.11, while the Farm and GP Range show a combined loss of \$4,822.21.

Total Operations YTD income is \$38,795.66. This is \$1,266.49 above the FY21-22 YTD budget.

Total Membership Income is \$31,545.13 (about 2.2%) below the FY21-22 budget amount.

Total YTD expenses are \$11,145.29 below FY21-22 budget.

FY21-22 Operations are \$10,601.23 above the YTD FY21-22 budgeted loss of \$5,433.33.

All Divisions except Gun Dog and Muzzleloader had a loss for the month of September.

Consolidated P & L shows a YTD Loss of \$26,549.79.

The YTD Gross income is \$74,453.57 while YTD expenses were \$101.003.36.
