Addendum by Jeff Eaton

Jeff Eaton reported that he had spoken with a person from the Kentucky Department of Fish & Wildlife Resources regarding state funding for dove fields. On the basis of federal regulations, Jeff's request for funding based on mentored hunting (supervised by BGSL) was denied, but an offer was made to fund a dove field on the condition that it be completely open to the public in season.

Jeff agreed with the BOD's opposition to opening an area of the club to the public for hunting without oversight or fees and supported the BOD's decision not to pursue this funding.

Committee Reports

Outdoor Recreation Committee (Trails, etc.)

Allen Carmical spoke regarding the Heartbreak Run & Gun event scheduled for later in February. He explained what the event entailed and what trails will be used during the event, stressing that preparation for the event would mark and partially clear significant trails for members to use later. Discussion followed, including a report on the proposed new Meadow Trail, which will be an easy trail around a large field to the north east of the newer fishing pond.

Training Committee

Joe Cerzosie with the Training Committee spoke about the training classes currently being scheduled at BGSL.
