Treasurer's Report: by Ron Summers

Dupree (DUTMA) Status

Since November 30, 2021 the Dupree account value has decreased by \$9,660.00. This is the result of current economic conditions. Currently we are depositing an average of \$700 a month in new funds and reinvesting bond interest earnings of around \$640 a month.

Total Cash All Bank accounts \$345,223.84

The Dupree account total value is \$285,389.25*

*Note: This includes \$69,000 for ammo purchase reserve and \$25,000 legal fees reserve.

Total YTD loss for Operations (Main Club, Farm and GP Range) is \$2,370.89. Main Club shows a total profit of \$21,181.34, the Farm and GP show loses of \$4,580.35 and \$18,971.88 respectively.

Net Income before for depreciation, non-budgeted project and capital expenditures is \$36,312.05 which is about a \$34.00 increase over December's amount of \$36,277.61.

Total Operations YTD income is \$197,786.78. This is \$10,140.95 above the FY21-22 YTD budget.

Total Membership Income is \$159,871.19. This is \$1,378.81 below the FY21-22 budget amount.

Total YTD expenses are \$21,976.17 below FY21-22 budget.

FY21-22 Operations are \$24,795.78 above the YTD FY21-22 budgeted loss of \$27,166.67.

For the Fiscal Year to date, Shotgun, Archery, Casting and Muzzleloader Divisions had losses while Pistol, Rifle, and Gun Dog Divisions had profits.
