### **Treasurer's Report: by Ron Summers**

Total Cash All Bank accounts \$303,051.56 Available funds for Main Club is \$134.000 The Dupree account total value is \$234,227.33 This includes \$25,000 legal fees reserve.

The bonds appear to have leveled off at around \$8.00 a share.

Total YTD loss for Operations (Main Club, Farm and GP Range) is \$54,916.67. This is a \$5,000.00 improvement over the previous YTD loss of \$59,949.96. This loss is the result of the approximately \$62,000.00 loss in bond value.

Net Income before for depreciation, capital expenditures and bond loss is \$74,986.04. Total Operations YTD gross income is \$374,703.33. This is \$6,186.40 below the FY21-22 YTD

budget.

Total Membership Income is \$315,121.48. This is \$7,378.54 below the FY21-22 budget amount.

Total YTD expenses are \$53,090.63 below FY21-22 budget.

FY21-22 Operations loss is \$9,536.73 above the YTD FY21-22

For the Fiscal Year to date, Shotgun, Archery, Casting and Muzzleloader Divisions had losses while Pistol, Rifle, and Gun Dog Divisions had profits. There was no report from Pistol for June.
