Treasurer Report (for August 2022): by Ron Summers

Total Cash All Bank accounts \$311,571.49 Dupree account total value is \$226,718.20 LPL Financial total value is \$5,955.07

Total loss for Operations (Main Club, Farm and GP Range) is \$57,863.45.

Main Club shows a net profit of \$13,765.33, the Farm and GP show losses of \$15,729.65 and \$55,899.13 respectively. The loss is the result of the approximately \$69,500.00 loss in bond value.

Net Income before for depreciation, capital expenditures and bond loss is \$97,767.68.

Total Operations gross income is \$466,458.79. This is \$16,808.79 above the FY21-22 budget, mostly due to the second sale of cattle.

Total Membership Income is \$380,516.41. This is \$6,483.59 below the FY21-22 budget amount. This reflects the multi-year trend of a 2% annual loss in membership.

Total expenses are \$53,169.16 below FY21-22 budget. Half of this savings is the result of not making any facility expansions and reduced payroll costs.

FY21-22 Operations loss is \$8,036.55 below the FY21-22 budgeted loss of \$65,900.00.

Consolidated P & L

The Consolidated P&L shows:

Income \$ 939,809.67

Expenses \$1,052,443.75 (\$69,502.66 in bond fund losses)

Net Loss -\$ 112,634.08

Capital Expenditures of \$119,716.94 will be moved to Assets at Fiscal Year-end which changes the Net Loss to a Net Profit of \$7,082.86.
