### **Treasurer Report: by Ron Summers**

Total Cash All Bank accounts \$373,610.23 Available for Main Club \$150K Dupree account total value is \$206,212.47 LPL Financial total value is \$5,847.41

At the end of October we have \$5,712.89 available for investing.

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$12,687.81.

This is before a loss on investments of \$19,019.03 resulting in a Net Loss of \$6,331.22.

Net Operating Income before Depreciation and Capital Expenditures is \$24,103.41.

Main Club shows an Operating Income of \$27,263.43, the Farm and GP show loses of \$6,068.25 and \$8,507.37 respectively.

Total Operations gross income is \$76,997.20. This is \$2,730.53 above the FY22-23 budget.

Total Membership Income is \$61,231.39. This is \$2,768.61 below the FY22-23 budget amount.

Total expenses are \$19,923.94 below FY22-23 budget.

FY22-23 Operations are performing \$22,654.48 better than the projected budget loss of \$9,966.67.
