Total Cash All Bank accounts \$343,168.10 Dupree account total value is \$211,988.73 LPL Financial total value is \$10,519.36

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$8,720.99.

Loss on investments is \$12,794.35 resulting in a Net Loss of \$4,073.36.

Net Operating Income before Depreciation and Capital Expenditures is \$31,556.39.

Main Club shows a Net Operating Income of \$40,185.46, the Farm and GP show losses of \$14,238.48 and \$17,225.99 respectively.

Total Operations gross income is \$164,303.02. This is \$15,769.69 above the FY 22-23 budget.

Total Membership Income is \$138,797.45. This is \$10,797.45 above the FY 22-23 budget amount. Membership renewal income is \$21,506.54 below YTD budget. Most of the short fall is offset by new membership income of \$19,463.99.

Total expenses are \$12,884.64 below FY22-23 budget.

FY22-23 Net Income is \$15,859.97 better than the projected YTD budget loss of \$19,933.33.

For the Fiscal Year to Date, Gun Dog, Muzzleloader, Pistol, Shotgun and Rifle have reported profits while Archery and Casting have reported losses.
