### **Treasurer Report: given by Ron Summers**

Total Cash All Bank accounts \$376,518.01 Dupree account total value is \$221,230.75 LPL Financial total value is \$11,160.35 Total available in Main Club account \$189,000

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$13,152.50. This is \$38,069.17 above the predicted YTD budget loss of \$24,916.67.

Loss on investments is \$2,106.14 resulting in a Net Gain of \$11,046.36. Net Operating Income before Depreciation and Capital Expenditures is \$41,697.80.

Main Club shows a Net Operating Income of \$52,604.71, the Farm and GP show losses of \$19,019.28 and \$20,432.93 respectively.

Total Operations gross income is \$200,452.17. This is \$14,785.50 above the FY22-23 budget.

Total Membership Income is \$172,176.19. This is \$12,176.19 above the FY22-23 budget amount. Membership renewal income is \$25,854.49 below YTD budget. Most of the short fall is offset by new membership income of \$23,810.68.

Total expenses are \$23,283.66 below FY22-23 budget.

FY22-23 Net Income is \$35,963.03 better than the projected YTD budget loss of \$24,916.67. For the Fiscal Year to Date, Gun Dog, Muzzleloader, Pistol, Shotgun and Rifle have reported profits while Archery and Casting have reported losses.
