Total Cash All Bank accounts \$398,470.07 Dupree account total value is \$220,364.31 LPL Financial total value is \$18,758.79 Main Club has \$187,000 available

We invested an additional \$7,000.00 in the LPL account in March.

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$12,671.60. This is \$47,557.93 above the predicted YTD budget loss of \$34,883.33. Loss on investments is \$805.45 resulting in a Net Gain of \$11,866.15.

Net Operating Income before Depreciation and Capital Expenditures is \$52,789.87.

Main Club shows a Net Operating Income of \$67,892.91, the Farm and GP show losses of \$27,869.12 and \$27,352.19 respectively.

Total Operations gross income is \$267,465.83. This is \$7,532.50 above the FY22-23 budget.

Total Membership Income is \$233,445.78. This is \$9,445.78 above the FY22-23 budget amount. Membership renewal income is \$34,983.79 below YTD budget. Most of the short fall is offset by new membership income of \$28,709.57 and Corporate Memberships of \$7,720.00 (Total of \$36,429.57).

Total expenses are \$40,022.44 below FY22-23 budget.

FY22-23 Net Income is \$46,749.48 better than the projected YTD budget loss of \$34,883.33. For the Fiscal Year to Date, Gun Dog, Muzzleloader, Pistol, Shotgun and Rifle have reported profits while Archery and Casting have reported losses.
