All amounts listed in this section have the \$200,000.00 of insurance proceeds deducted from the amounts shown in the P&L Operations Report. Net Operating Income for Operations (Main Club, Farm and GP Range) is \$24,364.57. This is \$69,214.57 above the predicted YTD budget loss of \$44,850.00. Net Operating Income before Depreciation and Capital Expenditures is \$77,036.97. Main Club shows a Net Operating Income of \$84,672.17, the Farm and GP show losses of \$25,185.83 and \$35,121.77 respectively. Total Operations gross income is \$344,074.11. This is \$9,874.11 above the FY22-23 budget.

Total Membership Income is \$289,721.01. This is \$1,721.01 above the FY22-23 budget amount. Membership renewal income is \$49,528.91 below YTD budget. Most of the short fall is offset by new membership income of \$33,949.92 and Corporate Memberships of \$7,720.00 (Total of \$41,669.92).

Total expenses are \$61,585.19 below YTD budget.

FY22-23 Net Income is \$69,214.57 better than the projected YTD budget loss of \$44,850.00.

For the Fiscal Year to Date, Gun Dog, Muzzleloader, Pistol, Shotgun and Rifle have reported profits while Archery and Casting have reported losses.
