**Farm / Operations Update: by Ben Riffell**

- Purple Paint law (property boundary lines) goes into effect in July.
- Bathhouse is open for the season. A new roof on the bathhouse is being installed.
- A local farmer is leasing farmland on BGSL property for grain fields.
- State turkey hunting is now closed. BGSL had 7 birds harvested with one of them harvested during youth season which was one of the turkey's that was banded by the state.
- Dove field is scheduled to be planted very soon.
- Rifle range has significant changes with the eyebrow installed. This will increase safety margins.
- The new cameras on the Rifle and GP Range have had positive feedback.
- The rifle range is now open from dawn to dusk, with advanced rifle qualifications.
- There will be a Hunters Education range day hosted before deer season.
- Dave Roberts said that Casting has 5 fishing poles available for use at casting ponds.
- The pond has recently been stocked. Members are allowed to take 2 catfish, other fish are catch/release.

- Cattle are currently doing well. A cattle sale is scheduled toward the end of the fiscal year.
- The club is leasing 2 bulls for 3-month periods. Calves will be born in the spring.
- The new shop was funded by an insurance settlement. Electrical service still needs to be installed.
