Total Cash All Bank accounts \$553,539.85 Dupree account total value is \$220,364.31 LPL Financial total value is \$51,426.25 Available in Main Club account \$292,000

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$7,928.65. This is \$27,928.65 better than the predicted YTD budget loss of \$20,000.00.

Net Operating Income before Depreciation and Capital Expenditures is \$19,907.12. This after year-end entries that move have adjusted out prior year expenses paid in the current fiscal year.

Main Club shows a Net Gain of \$18,484.43, the Farm a loss of \$4,088.64 and GP a loss of \$2,957.90.

Total Operations gross income is \$37,113.17. This is \$2,336.83 below the FY24-25 budget.

Total YTD Membership Income is \$29,470.55. This is \$3,487.78 below the FY24-25 budget amount. Total YTD expenses (which include \$6,475.72 in Capital Expenses) are \$30,265.48 below YTD budget.

FY24-25 Net Income is \$31,437.89 better than the projected YTD budget loss of \$20,000.00.

For the Fiscal Year to Date Casting, Gun Dog, Muzzleloader, and Pistol have reported profits while Archery, Rifle and Shotgun have reported losses

After Capital Additions removed Income \$74,347.32 Expenses \$66,776.46 Net Gain \$7,570.86 **Motion by:** David Roberts, 2nd by Nelson Bottoms to accept the Treasurer Report as presented. **Motion: Carries**
