Operations

Net Operating Income for Operations (Main Club, Farm and GP Range) is \$532.74. This is \$44,510.24 better than the predicted YTD budget loss of \$43,977.50.

Net Operating Income before Depreciation and Capital Expenditures is \$31,536.51.

Main Club shows a Net Gain of \$4,854.19, the Farm a gain of \$1,288.68 and GP a loss of \$6,809.10.

Total Operations gross income is \$81,349.31. This is \$2,449.31 better than the FY24-25 budget.

Total YTD Membership Income is \$59,123.99. This is \$6,792.68 below the FY24-25 budget amount.

Total YTD expenses (which include \$31,003.77 in Capital Expenses) are \$42,060.93 below YTD budget.

FY24-25 Net Income is \$43,311.27 better than the projected YTD budget loss of \$43,977.50.

Divisions

For the Fiscal Year to Date Casting, Muzzleloader, and Rifle have reported profits while Archery, Gun Dog, Pistol and Shotgun have reported losses

- <u>Cold Weather Update</u>: Bathhouse winterized; old archery and pistol water lines drained for winter
- Hunt update: Gun season just concluded; total harvest for property 11 antlerless & 4 antlered
- <u>CWD Drop off</u>: KDFWR pleased with the hunter participation; multiple counties of harvest represented; samples have been picked up and are going to the lab Dec. 3rd; est. 2-3 weeks to post results
- <u>Update on Pistol work</u> orders (gates for pit closures); requested signage ordered.
- <u>Update on MZ work</u> order: Hazard tree over the range has been felled; clean -up for next week.
- New Member update: 25 new members in Nov. 2024; NO Christmas certificates yet sold
 will try to update/advertise via FB and BLAST.
- <u>Kitchen Update</u>: functional at this time; lock installed on storage closet; Rapidly approaching investment commitment of 10k (new freezer delivered recently); requested walk-through and check list on all equipment delivered.
