Treasurer Report – Ron Summers

Total Cash All Bank accounts \$516,424.01 Dupree account total value is \$210,833.48 LPL Financial total value is \$52,834.62 Currently the Main Club account has \$292,000

Net Operating Income for Operations (Main Club, Farm and GP Range) is -\$47,805.70. This is \$42,149.30 better than the predicted YTD budget loss of \$89,955.00.

Net Operating Income before Depreciation and Capital Expenditures is \$64,015.64.

Main Club shows a net loss of \$44,924.12, the Farm a gain of \$10,181.93 and GP a loss of \$13,063.51. The Main Club's loss is mostly due to the expenditure of \$76,659.60 for the new shop, kitchen renovation and porch addition to Delabar Lodge.

Total Operations gross income is \$178,387.16. This is \$20,587.16 better than the YTD FY24-25 budget. Most of that is from cattle sales.

Total YTD Membership Income is \$129,499.31. This is \$2,334.02 below the FY24-25 budget amount. Membership renewals YTD are \$20,938.15 below the budget projection. Year-to-date there are \$18,166.13 in new Memberships.

Total YTD expenses (which include \$76,659.60 in Capital Additions) are \$24,618.47 below YTD budget.

Divisions

For the Fiscal Year to Date Casting, Gun Dog, Muzzleloader, Pistol, and Rifle have reported profits while Archery and Shotgun have reported losses.

Operation / Farm Report – Ben Riffell

- Buildings fared the cold weather relatively well.
- Roads were covered with ice and snow for several days.
- On or around December 20th the "Miller Welch" stone monument was damaged.
- The brass plaque has been placed on another stone and will be installed when the weather permits.
- After the board updated the First Responder policy, there were 100 brochures distributed to first responders throughout the county.
- Youth lodge had some water damage around the chimney. Currently we have 2 estimates for repair. Discussion followed. The board leaned toward not patching but completely fixing the problem. Tarps have been providing cover temporarily.
- Targets at Rifle have been repaired and installed.
- A tree at Muzzle Loader has been removed.
- The KDFWR have requested to use the grounds for bird watching.
- During Christmas there were 5 new membership gift certificates sold, 2 renewals, and 1 gift certificate for Shotgun.

New Business

After hours shooting – Currently there are no rules stating "No Night Shooting" After discussion on the matter, Walter asked Ben to send a letter to the board for their review. The discussion will resume at the next meeting.

Investments – Ron gave the board an update of the club's investments. Currently we have 80% with Dupree and 20% with LPL Financials (Vanguard) After discussion the board decided to continue with the 80/20 split.

Burton is working toward providing new member orientation online.
